COUNTY SUPERVISOR: None.

FIRE DEPARTMENT: Pierce reported that the Davis City Council voted to reduce firefighter staffing levels from 12 to 11 per shift and to rework the way fire fighters respond to calls. The new staffing configuration will save the city approximately \$437,000 per year. A July 1, 2013 deadline has been set for implementation of these changes.

Pierce reported that there has been no activity on the hiring of a fire chief.

SECRETARY/CLERK INVOICE: Weaver submitted an invoice in the amount of \$293.85 for the month of April 2013. On a motion by Boutin, seconded by Reynolds, the invoice was approved by unanimous vote.

APPROVAL OF ASSESSMENT FOR TAX ROLL: Not discussed.

DAVIS ENTERPRISE ADVERTISING INVOICE: The advertising invoice was paid by the City of Davis.

SECRETARIAL/CLERK AGREEMENT: Weaver submitted an agreement for secretarial/clerk services for the period May 15, 2013 – May 15, 2014. Currently Weaver is paid \$51.88 with a mileage reimbursement equal to the Internal Revenue Service mileage rate (.565). The Commissioners decided to increase her hourly rate by 2% with the same mileage reimbursement agreement. The new hourly rate will be \$52.92. On a motion by Boutin, seconded by Reynolds, the new terms of the contract were approved by unanimous vote.
